By 'control', we mean persons who exercise significant influence over the organisation, such as directors and persons who have special voting rights or preference shares in the organisation, or who have the right to appoint or dismiss directors or supervisory directors of the Organisation, or who otherwise exercise significant influence within the organisation. If there is no one to whom the above is applicable, then the organisation's executives are its UBO.

We may use the data you enter for the following purposes:
